## APPLICATION FOR RAW CASHEWNUT BUYING LICENSE FOR EXPORTATION AND OR LOCAL PROCESSING

The Cashewnut Board of Tanzania, wishes to inform all 2021/2022 Prospective buyer's that, the new season for 2021/2022 will officially open on 1st September 2021 and sales auctions will commence on 24<sup>th</sup> September, 2021.

The Board has started to issue Raw Cashewnut buying license online through Agricultural Trade Management Information System under the Ministry of Agriculture (ATMIS).

1. The following should be submitted:
  - i. Colored passport size picture of one of shareholders and certified copies of:
  - ii. Valid Business License
  - iii. TIN Certificate
  - iv. Certificate of Incorporation/Registration
  - v. Valid Tax Clearance Certificate
  - vi. Valid VAT Certificate
  
2. Last season registered companies are required to update their particulars and attach certified copies of:
  - i. Valid Business License
  - ii. Valid Tax Clearance Certificate
  - iii. Valid VAT Certificate

Through [www.atmis.kilimo.go.tz](http://www.atmis.kilimo.go.tz), and apply for the new raw cashewnut buying licence for 2021/2022 crop season

3. All online Registered and verified raw cashewnut buyers are required to deposit their bid securities which depends on the quantity intended to be bought in the specific auction, before being issued buying license as per categories narrated below:

Categories of bid securities as per quantity versus bid amount are as hereunder:-

<b>TONES PER AUCTION</b>	<b>AMOUNT( Tshs)</b>
50-100	20,000,000.00
101- 250	50,000,000.00
251- 500	100,000,000.00
501 - 1000	300,000,000.00
1001- 3000	500,000,000.00
3001 and above	1,000,000,000.00

**NB:** *Local Processors are allowed to procure less than 50 tones in the auction and they will not be required to deposit Bid Security, instead they will be required to submit Bank Guarantee before participating in the auctions. However, there is special guidelines which enables local Processor's to procure direct through primary market.*
