RAW CASHEWNUTS MARKETING AND SALES GUIDELINES FOR THE YEAR 2022/2023 CROP SEASON

1. A bidder must have raw cashew nut buying license for the 2022/2023 crop season issued by the Cashewnut Board of Tanzania (CBT) after depositing bid security.
2. Each bidder should bid on basis of one bid(offer) for each Sales Catalogue(Warehouse).
3. Each bidder shall physically drop his bid in the tender box at cooperative Union offices one day before auction day from 0800hrs to 1700hrs E.A.T and thereafter, tender box will be opened on the next auction day at auction site starting from 1000hrs.
4. Highest bidder/s will be announced at the auction site after the farmers have agreed to sale
5. A buyer shall submit bid security in cash deposit in favor of the Cashewnut Board of Tanzania, the amount of bid security fall under the following categories;

6. Raw cashewnuts stored in the warehouse shall be sold in two distinguishable quality grades which are standard grade (Shelling Outturn \geq 48 lbs/80 Kg bag) and under grade (Shelling Outturn $<$ 48 \geq 44 lbs/80 kg bag).
7. The minimum bidding quantity shall be 50 metric tons of raw cashewnuts, except for local processors.
8. The licensed buyer will be provided with sales catalogue 12 hours before auction.
9. The bidding price shall be Ex-warehouse.
10. The sale unit shall be per Kilogram(Kg) in Tanzania shillings (TZS).
11. Successful bidder shall collect sales invoice from respective Cooperative union's office within 24hrs after auction.
12. A bidder shall not bid in excess of the quantity attached to his respective bid security. If that happens, he should submit the banker's cheque to the respective union with the amount value equal to the excess raw cashew nut to be bought.
13. Payments for the invoice shall be in full and must be effected within four (4) working days from the date of the invoice.
14. The buyer shall present the original Warehouse receipt and Release Warrant to the respective Warehouse Operator for the collection of the purchased cashewnuts as per Cashewnut marketing and Sales guidelines.
15. The successful bidder shall be required to pay Storage charges of TZS 52/= per Kg to Warehouse Operator, gunny bags charge of TZS 80.46/= per Kg to the respective Cooperative union, Contribution for cashew development of TZS 110/= per Kg and Export Levy equivalent to 160 USD per metric ton or 15% of FOB value(whichever is high), to Tanzania Revenue Authority (TRA)
16. Mode of payment shall be in banker's cheque/TISS to the respective Union bank accounts and the buyer shall receive the original Warehouse Receipt and Release Warrant from respective Cooperative Union after payment.
17. The buyer shall sign certificate prepared by the warehouse operator describing Quantity and Quality of RCN collected from the warehouse
