#### RAW CASHEWNUTS MARKETING AND SALES GUIDELINES FOR THE YEAR 2022/2023

i. A bidder must have raw cashew nut buying license for the 2022/2023 crop season issued by the Cashewnut Board of Tanzania (CBT)

ii. The sale of RCN will be conducted through auctions in which buyers will submit their offer in sealed envelopes on the basis

of one bidder, one bid for each catalogue (warehouse)

iii. Each bidder shall physically drop his bid in the tender box at Cooperative union office one day before auction day from 0800Hrs to 1700hrs

and thereafter tender box will be opened on the next auction day at action site starting from 1000Hrs

iV. Highest bidder/s will be announced at the auction site after the farmers have agreed to sale.

v. Raw cashewnuts stored in the warehouse shall be sold in two distinguishable quality grades which are standard grade( Shelling Outturn  $\geq$  48 lbs/80Kg Bags)

and under grade (Shelling Outuurn <  $48 \ge 44 \text{ lbs}/80 \text{ kg bag}$ )
