

CASHEWNUT BOARD OF TANZANIA

RULES AND SALES CONDITIONS FOR THE 2024/2025 CROP SEASON

The Cashewnut Board of Tanzania (CBT) wishes to inform all Raw Cashewnut prospective buyers that, the new season for 2024/2025 will officially commence on 1St September 2024 and sales auctions will commence on 11^{tt} October 2024.

The CBT has already started to issue Raw Cashewnut buying licenses online through Agricultural Trade Management Information System under the Ministry of Agriculture (ATMIS).

1.0. PROCEDURES TO APPLY FOR RAW CASHEWNUT BUYING LICENCE

- (i) Register online through <u>www.atmis.kilimo.go.tz</u>
- (ii) All applications should be attached with one colored passport size picture of one of the company directors and certified copies of:
 - TIN certificate;
 - Company's Certificate of Registration/Incorporation;
 - Valid Business License;
 - Value Added Tax (VAT) Registration Certificate; and
 - Valid Tax Clearance Certificate.
- (iii) Last seasons registered companies through (ATMIS) are required to update their particulars and apply for new cashewnut buying license with attached certified copies of:
 - Valid Business License;
 - Valid VAT Certificate; and
 - Valid Tax Clearance Certificate.
- (iv) All online registered and verified raw cashewnut buyers are required to deposit their bid security amounts before being issued a buying license by CBT. The bid security amount depends on the quantity of RCN intended to be purchased for each auction, as per categories narrated in the table 1 below;
- (v) Local Processors have special arrangement to procure RCN through primary market (refer special guidelines) however they are also allowed to procure RCN in the auctions in which they can buy even less than 50 tons/auction and will not be required to deposit Bid Security, instead will be required to submit Bank Guarantee before participating in the auctions (this arrangement is strictly for local processors only).

NOTE: The Bid Securities are refundable to buyers upon written request and after fulfillment of their obligations thereof for all cashew nuts bought during the season.

2.0. BUYING PROCEDURES

2.1 GENERAL INFORMATION

- i. A bidder must have raw cashew nut buying license for the 2024/2025 crop season issued by the Cashewnut Board of Tanzania (CBT);
- ii. The sale of RCN will be conducted at auctions through an electronic system under the management of the Tanzania Merchantile Exchange (TMX);
- iii. The buyer who has completed the registration process and deposit Bid Security to the Tanzania Cashewnut Board of Tanzania will be registered into the TMX electronic sales system.
- iv. The buyer will register in the TMX system by filling out a consent form to participate in auctions.
- v. Auctions will be held online (in a competitive manner) and buyers can participate wherever they are in an area with internet access.
- vi. Buyers shall compete to buy by Lot (One Lot is the amount of cashews delivered to the relevant grade based on the amount of cashews in the warehouse). One Lot takes one minutes and if a buyer has set a price, then it will repeat for 40 seconds until another buyer set another price;
- vii. Highest bidder/s will be announced at the auction site after the relevant Cooperative Union on behalf of the farmers approves the offered prices;
- viii. Raw cashewnuts stored in the warehouse shall be sold in two distinguishable quality grades which are Standard Grade (Shelling Outturn ≥ 48 lbs/80 Kg bag) and Under Grade (47 ≥ Shelling Outturn ≥ 44 lbs /80 kg bag);
- ix. The minimum bidding quantity shall be 50 metric tons of raw cashewnuts, except for local processors;
- x. The licensed buyers will be provided with sales catalogue 12 hours before the auction;
- xi. The bidding price shall be ex-warehouse;
- xii. The sale unit shall be per Kilogram in Tanzanian Shillings (TZS);

xiii. Successful bidder shall collect sales invoice from the respective Cooperative Union within 24 hours after the auction;

xiv.Payments for the invoice shall be in full and must be deposited within five

(5) working days from the auction date through respective accounts as described in the invoice issued by the Cooperative Union. Delays in payment will subject the buyer to penalty as described below: -

- a) If the price of the resold cashew will be lower than the original auctioned price, the Bid Security deposited by the buyer will cover the difference in price to the farmer.
- b) If the price of the resold cashew will be higher than the original price or equal to the original price, the buyer who failed to pay for the cashews on time will be penalized by paying five percent (5%) of the value of the cashews he failed to pay on time.
- c) If the buyer is penalized and his security deposit amount is reduced; The buyer will be allowed to continue to participate and buy cashews in the auctions according to the amount of Security Bond remaining, or he will have to top up the Security Bond to cover the deducted amount. If he fails to top up the amount of Security Bond and the amount remained is below the set levels, the buyer will not be allowed to continue participating in the auctions.
- xv. A bidder shall not bid more than the quantity attached to his respective bid security. If that happens, he should write "commitment letter" and submit the banker's cheque with the amount value equal to the excess raw cashew nut to be bought;

xvi. Charges and levies paid by buyer are as follows;

- xvii. Mode of payment shall be in banker's cheque/TISS to the respective bank accounts. After payments the buyer shall receive the original Warehouse Receipt and Release Warrant from respective Cooperative Union.
- xviii. The storage period for raw cashews after sales is 14 working days, these days will start counting after five (5) days of payment (these days will not include Saturdays and Sundays). After 14 days, the buyer will pay an additional cost of storing raw cashews TZS 5 per kilogram per day for the next 14 days only. These charges will be paid directly into the Account of the Warehouse Operator/Collateral Manager.
- xix. The Warehouse Operator/ Collateral Manager will issue purchased cashewnuts to

the respective buyer after receiving and verifications of the original Warehouse Receipt and Release Warranty from the Cooperative Union;

- xx. The buyer shall sign certificate prepared by the Warehouse Operator/ Collateral Manager describing Quantity and Quality of RCN collected from the warehouse.
- xxi. The raw cashewnuts from Mtwara, Lindi and Ruvuma regions must be shipped through Mtwara Port. Consequently, raw cashewnuts from other areas, shipping can be done through Mtwara, Dar es Salaam and Tanga ports.
- xxii. The permits that will be issued electronically by the Cashewnut Board of Tanzania (Produce Dispatch Note-PDN) to transport cashews within the country will be valid for 48 hours after being issued. In additional, all raw cashews will be transported within a day in the country from 12 am to 12 pm throughout the season. Any act of violating this directive shall be punished according to Cashewnut Act No.18 of 2009 and its regulations of 2010.

Unlicensed buyers are not allowed to buy cashewnut and participate in the auctions in the season of 2024/2025. If found participating without license legal actions shall be taken against the company.

Cashewnut Board of Tanzania (CBT) will keep on updating buyers on Rules and Guidelines through website <u>www.cashew.go.tz</u>. OR CBT branches: Dar es Salaam, Tunduru, Tanga, Nachingwea and Manyoni. In addition, the cost will not involve cashews with quality challenges. Also, buyers should go through the Cashenut Marketing and Sales Guidelines for the Season 2024/2025 for more details.
